2.	<p>MINUTES OF PREVIOUS MEETING</p> <p>The minute of the previous meeting held on the 13th September 2019 was tabled for comment. It was noted the lack of representation from Police Scotland and Fire Scotland Service, Neil agreed he will write a letter to both services highlighting the lack of representation. The Committee agreed the minutes were an accurate reflection of the meeting.</p>	Neil Kerr
3.	<p>MATTERS ARISING</p> <p>The matters arising were captured on the agenda and followed up on the ongoing matters. It was agreed the below would be carried forward to the next Committee meeting in December:</p> <p><u>Rights, Respect, Recovery</u></p> <p>It was agreed that the new secondment would be invited to present to the ADP at an appropriate future juncture – Liam advised the Committee no one is in post.</p> <p><u>DAISY</u></p> <p>Liam Wells will recirculate the DAISY paper when he returns from leave for Committee Members to provide comment on. Liam advised the Committee the last letter received was October with no further update.</p> <p><u>Scottish Government</u></p> <p>Neil advised Committee he wrote to Scottish Government asking for 5 year confirmed funding to help with future planning. Neil was advised this would not be possible however budgets will be agreed sooner. It was agreed Dale and Liam will prepare a funding report for IJB approval aiming for April/May.</p>	Dale Meller / Liam Wells
4.	<p>RECOVERY COORDINATOR</p> <p>Liam tabled the Recovery Coordinator paper noting the purpose of the report is to update the ADP Committee on the progress and activity of the Recovery Coordinator. Liam noted Caroleann was appointed in May and the ADP Committee requested 6 monthly updates. It was noted within the report this role has four key functions:</p> <ul style="list-style-type: none"> • To Map out existing recovery provision • To promote partnership working via periodic stakeholder meetings • To promote best practice sessions via periodic stakeholder meetings • To promote the establishment of an East Ayrshire Forum 	

	<p>Caroleann advised the group is settling well and has been spending a lot time with services/groups letting herself be known in the community. Caroleann noted she has been well received all groups have been open and are looking to work in partnership. The Committee was advised Peer Advocacy workers from EAAS are looking into making recovery more visible in East Ayrshire. Caroleann advised the group she is looking into developing an East Ayrshire Recovery website. The aim of this is to enhance visibility creating online tools and sign posting to other organisations for support. The Chair asked Caroleann what her biggest challenge was; her reply was people not willing to engage and people only looking into their own group not looking wider at other organisations. Dale raised the question around the relationship between the ADP and service groups, Caroleann advised she is the key link between the Committee and service groups being able to provide background knowledge around applying for funding, ADP monitoring and creating more positive relationship. Another question was raised around duplication of services – Caroleann advised there is some cross cutting with groups due to solo working. However Caroleann is looking at creating a group forum linking this to the website providing timetables for groups as well as linking Council/NHS services.</p> <p>The following recommendations were agreed:</p> <ol style="list-style-type: none"> I. <p>5.</p>	<p>SALSUS</p> <p>Liam introduced the SALSUS report advising the purpose of the report is to provide the ADP with information regarding the recently published SALSUS report on alcohol and drug use in 13 and 15 year old in East Ayrshire.</p> <p>The 2018 Scottish Schools Adolescent Lifestyle and Substance Use Survey (SALSUS) is the latest in a national series of surveys of smoking, drinking and drug use among secondary school children. The survey is conducted on a biennial basis, targeting secondary school pupils in local authority and independent schools. Graphs were inserted within the report to show the alcohol and drug use in 13 and 15 year olds in East Ayrshire, overall stable trend in relation to young people ever having an alcoholic drink, ever been drunk and offered drugs. There is a decreasing downward trend in relation to young people who have had a drink in the last week and ever tried drugs.</p>	

	<p>It was agreed Neil Kerr will link with Eddie Fraser, Director to see if this report can be shared and tabled at the Children and Young People's Strategic Partnership Group. It was also agreed Neil and Liam Wells will contact Anne Kennedy at Ayrshire College to look at partnership working.</p> <p>The following recommendations were agreed;</p> <ul style="list-style-type: none"> i. Liam advised that earlier this year the development fund was established with a budget of £30,000 to be used to support small one off local projects up to a maximum of £5000 as well as also offering the opportunity for sustainability among other groups and organisations.</p> <p>Noted within the report the ADP Advisory Group is looking for the fund to be increased to £60,000. Discussion was had around the possibility of this funding being participatory funding where groups can pitch ideas to a panel for voting. It was agreed Caroleann will work with organisations to look into this.
