### JOINT COMMUNITY EVENTS

The Games Hall Sub-Committee are planning to take on the facility as a lease in October 2018. The AM Brown Institute Sub-Committee are hoping to purchase the facility in April 2019 and carry out some considerable capital works to make the building sustainable into the future.

## COMMUNITY COHESION



Catrine has always seen a high level of community activity and over the years have had many successful projects and events, from environmental to activity and social. Previously, it was felt that groups and events were competing against each other and therefore struggled to remain sustainable or popular over time.

East Ayrshire Council historically managed Catrine Community Centre and Catrine Games Hall, which were becoming financially unsustainable due to lack of use. Catrine Community Trust own and manage the CEVIC Centre, which acts as a Heritage Interpretation Centre.

# What are the achievements so far?

## PARTICIPATORY BUDGETING



Vibrant Communities were successful in obtaining £10,000 from the Big Lottery for the CAP Steering Group to hold a local PB Event in Catrine. Groups were able to bid for money if they were carrying out actions from the recently launched Community Action Plan.
