Sarah opened the meeting explaining that this was a pre meeting to the Joint Cabinet Meeting on the 20th to ensure everyone was in agreement to the topics they agreed to take forward for the next year. Due to the legal update on Vaping and Scottish Government taking a more hands on approach to this, the Youth Cabinet agreed that they would omit this from their campaign work and take forward:

- 1. Skills for Life
- 2. Mental Health / Health and Wellbeing
- 3. Road Safety / Awareness

As the subjects they want to work on for the next year.

Sarah introduced Colin Hastings from Finance for an update to the previous meeting with Joe McLachlan earlier in the year.

Colin thanked Sarah and explained that he had a brief update for the Youth Cabinet he stated that the feedback particularly that from the new younger members was very constructive and the previous consultation with Cabinet Members on EAC Financial and Strategic Plans has taken these on board as part of the way forward.

Colin also stated that they are still working with Ian Tough in new forward thinking consultation processes with staff being in attendance spending time in communities and listening events which will have Youth Cabinet members present to add to the voice of young people and not just adults in the communities.

Colin thanked everyone for their contributions with many questions being asked for example – costs of school transport and why new buildings etc.

Further to Joe's announcement regarding a block of funds being available, the Cabinet will also be asked to make recommendations in the future at planned events as to how this can be best spent in the Kilmarnock Area for young people, and to think about what might be required, remembering that this is a one off spend but hoping to spread it over ten years.

Some of the challenges were discussed with the Cabinet recently by Joe about the demographic shift in East Ayrshire population and how this may affect school numbers and reduce the number of schools in the future, this may also be something to think about when making recommendations.

Sarah thanked Colin for his input and agreed that they would discuss recommendations further as a group.

Sharron and Hannah were asked to take the floor and give their presentation on Place Based Investment Regeneration.

Sharron spoke about the Money and Fund that they have and an explanation of the Capital which has been advertised for applications which close at the end of March.


The process consists of a community scoring group and an officers/strategic group.

Adam also said he would like to meet up with those on the Skills for Life Group to discuss some ideas with them about going forward and using partners and others within Vibrant Communities to help. Sarah agreed to set this up.
