East Ayrshire HSCP Strategic and Performance Framework

The Partnership's performance framework and the content of the Annual Performance Report align with the strategic policy arrangements set out in Section 1. This includes the suite of measures which underpin the National Health and Wellbeing Outcomes and the performance reporting requirements set out by the Public Bodies (Joint Working) (Scotland) Act 2014. The Report fully adheres to the performance reporting Guidance issued under this legislation by the Scottish Government.

In line with Guidance, the Report presents an assessment of performance reflecting the extent to which the Strategic Plan 2021-30 is contributing towards fulfilling the National Outcomes, including the decision-making of the Integration Joint Board and financial performance over the 2018/19 - 2024/25 period. Key performance measures have been cross-referenced and incorporated from the core suite of integration indicators under the national Health and Wellbeing Outcomes, the Wellbeing Delivery Plan local outcome indicators, Statutory Performance Indicators, the Ministerial Strategic Group core dataset and measures from performance scorecards included within local Service Improvement Plans. The measures reported therefore align to the delivery of the HSCP's Strategic Plan 2021-30, the East Ayrshire Community Plan 2015-2030 and the National Outcomes, as illustrated below. The Report also includes narrative and delivery examples in relation to our local performance journey over the 2024/25 period, highlighting areas of key activity, service developments and personal experiences, aligned to the 15 national outcomes for health and wellbeing, children and justice, and our Strategic Priorities.
