	<p>Planning Partnership on 17<sup>th</sup> September and NHSAA Board on 5<sup>th</sup> October 2020 to provide a review on performance on delegated budget during 2019/20.</p> <p>The Board welcomed and approved the report and thanked the Team for the hard work in producing this document. The report was positive, noting real progress and improvement across services. Eddie Fraser added his thanks to the officers who developed this report and highlighted the hard work of our mental health teams who with additional resources have dramatically reduced waiting times.</p>
<p><b>Housing Contribution Statement</b></p>	<p><b>Michael Byers, Planning and Performance Officer</b> presented the Housing Contribution Statement, ('HCS') covering the period 2019-2022, which is an integral part of the Health and Social Care Partnership's Strategic Plan 2018-21.</p> <p>This successful partnership approach has been central to the delivery of a number of key initiatives which have positively contributed to health and well-being of East Ayrshire residents.</p> <p>The Board welcomed and endorsed the report and recognised the value of this strong relationship with housing partners to deliver this ambitious housing programme. In particular for our residents who require additional support and have benefited from new supported and accessible housing.</p>
<p><b>East Ayrshire Health and Social Care Partnership Equalities Mainstreaming and Outcomes Report 2020.</b></p>	<p><b>Michael Byers, Planning and Performance Officer</b> presented the East Ayrshire Health and Social Care Partnership Equalities Mainstreaming and Outcomes Report 2020.</p> <p>The Board endorsed the report and noted the focus on promoting equality and our progress in mainstreaming equalities into the Partnership's day-to-day business processes.</p>
<p><b>Final Audited Accounts 2019/20</b></p>	<p><b>Craig McArthur, Chief Financial officer</b> presented and advised the IJB of requirements introduced by the Local Authority Accounts (Scotland) Regulations 2014, to submit Annual Accounts for the year ended 31 March 2020 to the IJB for approval and thereafter forward the Accounts to the Controller of Audit.</p> <p>The draft audited Annual Accounts 2019/20 were presented to the Audit</p>

	and Performance Committee along with the External Audit draft ISA 260 report on 11 August 2020. The Board approved the accounts.
External Audit Plan	<p><b>Pat Kenny, Deloitte</b> are the external auditors to the IJB and presented the report. This is a very positive report which is unmodified, with no issues identified and no major recommendations for improvement.</p> <p>The Board welcomed the report and thanked Alex McPhee for the close stewardship of the financial reporting to the IJB. It was also noted that the accounts had not been delayed as a result of Covid 19 due to the hard work of officers.</p>
Annual Report – Audit & Performance Committee	<p><b>Lisa Tennent, Chair of the Audit and Performance Committee</b> presented the 2019/20 Audit and Performance Committee Annual Report for consideration and to provide assurance to the IJB that governance arrangements and internal controls are adequate for the IJB.</p> <p>The Board welcomed and thanked the Committee for their work over the year. It was recognised that the Committee has delegated responsibility from the IJB to oversee the Transformation Fund which provides support for the innovation and service redesign through the Strategic Commissioning Board.</p>
Financial Management Report - 31 July 2020	<p><b>Alex McPhee, Senior Manager</b> presented the report and provided detail of the projected outturn position for the East Ayrshire Health and Social Care Partnership for 2020/21, based upon the current financial position as at 31 July 2020 (month 4).</p> <p>The consolidated projected outturn for the Partnership on directly managed services is an overspend of £6.646m. This represents 2.5% of the £262.649m directly managed services budget for the year. The projected overspend position is primarily due to costs relating to the response to the ongoing Covid-19 pandemic, with projected costs included in the most recent mobilisation plan submitted to the Scottish Government totalling £9.615m and comprises projected overspends of £4.043m and £5.572m on services commissioned from the Council and NHS Ayrshire &amp; Arran respectively.</p>

	<p>The Board approved the report. It was recognised that during 2020/21 the impact on services as a result of Covid 19 will be felt and this close financial management approach will ensure we are able to deliver better outcomes for residents alongside budgetary control.</p>
<p><b>Independent Care Review – The Promise</b></p>	<p><b>Clare Wilson, Senior Manager</b> presented the report to outline the recent Independent Care Review and request the IJB sign up to The Promise.</p> <p><b>The Promise</b> recognises several reviews of the care system over the past several years have failed to have the impact required to truly change the care experience for our most vulnerable children and young people. The previous barriers to effect change have included a lack of buy-in for change, no money to invest in the changes needed, restrictive rules preventing change and not knowing how to make the changes needed.</p> <p>The Promise and lays out the five foundations the review is based upon. It outlines the powerful voice of over 5,500 young people and the importance of corporate parents to listen and respond to this. Corporate parent partners have begun the journey of identifying strengths and challenges which are outlined in this report. Next steps will be to have further discussions about The Promise through the Corporate Parenting Strategic Group to ensure a holistic approach and ownership of the key messages for all partners.
