What is the Interim **Environmental Report?**




The <u>Interim Environmental Report (PDF 2.07Mb)</u> forms part of the preparation process for the next Local Development Plan, which is required to undergo a **Strategic Environmental Assessment (SEA)** in accordance with the Environmental Assessment (Scotland) Act 2005.

The Environmental Assessment (Scotland) Act 2005, requires that a Strategic Environmental Assessment be undertaken at various stages through the preparation process:

- □ Scoping Report
- **☐** Main Issues Report (Current Stage)
- □ Proposed Plan

The Interim Environmental Report considers and assesses the significant environmental implications of the main issues and approaches contained within the Main Issues Report.





How are environmental impacts assessed?



In order to assess the environmental impact of the Main Issues Report, we have grouped and defined aspects of the environment into **five broad categories** (Environmental Topics) each of which have a number of associated environmental receptors.

Environmental Topic	Receptors
Natural Features	Landscape Biodiversity, Flora and Fauna Climatic factors
Natural Resources	Soil Air Water (including surface water, groundwater and GWDTE)
Historic Environment	Listed Buildings Conservation Areas Scheduled Monuments Archaeological Sites Gardens and Designed Landscapes Historic Battlefields
Social Environment	Health Population Material Assets (infrastructure, amenity and recreational open space i.e. parks etc)







Stage 1

Stage 1 considers what the environmental impacts may be and whether they are likely to be significant (Yes/No/Unsure). It also considered whether impacts are likely to be cumulative or synergistic.

Cumulative impacts can arise from the combined effects of the plan. They can also arise from interaction between different components of the plan.

Synergistic effects occur when two or more effects identified within an assessment, are capable of working together to create a new effect, or a magnitude of effect which does not arise from the individual effects

We use the Council's Geographic Information System (GIS) as a sifting tool to identify any potential impacts.

In order to assess any significant environmental impacts, we adopted a two stage methodology:

Stage 2

Stage 2 analyses and assesses the identified significant impacts outlined in Stage 1 in greater detail, in relation to each of the individual environmental components.

The Stage 2 assessment also looks at short, medium and long terms environmental impacts and provides proposals to monitor significant impacts.

Each box is **colour coded** to indicate whether the impact is significant positive, significant positive/negative, significant negative or neutral.







The <u>Monitoring Statement (PDF 4.83Mb)</u> provides and summarises the evidence base for Local Development Plan 2.
