2. DECLARATIONS OF INTEREST

There were no declarations of interest intimated by the Board Members.

3. MINUTE OF MEETING

The Minute of the meeting of East Ayrshire Licensing Board, held on 20 May 2025, was approved and noted.

Referring to the Board's decision to hold a Personal Licence Review Hearing, the Clerk advised that a Special Board meeting had been arranged for 8 July 2025 at 2pm.

4. APPLICATIONS CONSIDERED UNDER DELEGATED AUTHORITY

The Clerk reported on the applications discharged under delegated authority between 12 May and 13 June 2025, namely:-

The Clerk reported that of the 68 Occasional Licences granted, 28 were granted to Personal Licence holders, 15 to Club Premises, 14 to Premises Licence holders and 11 to Voluntary Organisations.

It was noted that, as of the date of the report, there are 921 Personal Licences in force, an increase of 14 since the last report and 289 Premises Licences in force, a reduction of 1 since the last report.

6. ANNUAL FINANCIAL AND FUNCTIONS REPORT

The Clerk reminded Members that, in terms of Section 56 of the Air Weapons and Licensing (Scotland) Act 2015, Licensing Boards must prepare and publish an Annual Financial and Functions Report.

The Clerk outlined the contents of the report and Members noted that there was deficit of £54,816 in 2024/25. The Clerk referred to the reduction in staff costs in the year 2024/25 and explained that this was due to the relaxation on employers' pension contributions.

The Board Members unanimously agreed to approve the Annual Financial and Annual Functions Report and authorised the Clerk to proceed with the publication of the Annual Financial and Annual Functions Report.

7. PREMISES LICENCE REVIEW

Review of premises licence for premises known as Nisa Newmilns, 57-59 Main Street, Newmilns following receipt of a Premises Licence Review Application in terms of Section 36(3)(b) of the Licensing (Scotland) Act 2005 from the Regulatory Services Manager, East Ayrshire Council.

The Clerk advised that, following receipt of submissions from the Agent for the licensing holder, a request had been made by Food Standards Scotland to continue consideration of the Review Hearing to allow matters to be investigated further.

Mr James Lamb, Solicitor, appeared on behalf of the applicants. He reminded Members that the premises previously held a licence and operated as Dragon Royale. The licence had however lapsed.

Mr Lamb advised that, should the Board be minded to grant the licence, the premises would be sold as licensed premises and that the premises would thereafter operate as an Indian Restaurant.

As there was no objections or representations in respect of the application, the Board agreed unanimously to grant the licence.
