NEW CUMNOCK COMMUNITY ACTION PLAN

This Community Action Plan summarises community views about:

- New Cumnock now
- the vision for the future of New Cumnock
- the issues that matter most to the community
- our priorities for projects and action.

The plan is our guide for what we - as a community - will try to make happen over the next 5 years.

NEW CUMNOCK COMMUNITY STEERING GROUP

The preparation of the Action Plan has been guided by a local steering group which brought together representatives from Afton Water Leisure (NC Swimming Pool), Glenafton 99's, Improving New Cumnock (INC), New Cumnock Environmental Regeneration Volunteers (NERV), New Cumnock Community Association, New Cumnock Community Council, Glenafton Athletic, New Cumnock Disabled Club, New Cumnock Parish Church and local residents.

LOCAL PEOPLE HAVE THEIR SAY

The Action Plan has been informed by extensive community engagement carried out over a five month period from May 2013 to September 2013.

The process involved:

- stakeholder interviews and focus group meetings - with different groups and individuals representing all aspects and ages of the community;
- a community views survey, which was delivered to all households;
- a children's views survey, conducted through the primary school
- preparing a community profile detailing facts and figures about the community;
- a Community Futures Event.

664 COMMUNITY VIEWS SURVEY FORMS WERE RETURNED FROM OUR **1,500** HOUSES

107 SURVEY FORMS WERE RETURNED FROM THE PRIMARY SCHOOL

FACTS AND FIGURES

We have summarised below some of the main facts and figures from the Community Profile – a report produced by the Steering Group to give a picture of New Cumnock now.

LOCATION

New Cumnock is the 'gateway' to East Ayrshire and close to the boundary with Dumfries and Galloway. It is on the A76 the main road between Dumfries and Kilmarnock.

POPULATION

The village and surrounding rural area has a population of around 2,600 - a decline of over 17% in the last decade. The largest reduction is in the number of children and working age adults, with an increase in the number of people of pensionable age. Over 30% of the population are over 60 compared with 24% for East Ayrshire and 23% for Scotland. These trends reflect a continuing loss of population over the 40 years since the closure of the coal mines.

HOUSING

There are just under 1,500 houses in New Cumnock with a significantly high percentage of social rented housing and low levels of owner occupied housing compared to East Ayrshire and Scotland.

EMPLOYMENT AND THE LOCAL ECONOMY

Loss of the coal mines by the end of the 1960's was a devastating blow to our still resilient community and it has been hard to replace as a source of local employment. Unemployment is higher than the East Ayrshire and Scottish average with nearly a quarter of working age people claiming out of work benefits. The decline in employment and income to the community is reflected in the village with a loss of shops and closure of the local hotel.

Open cast mining has continued as a smaller employer but in 2013 a further blow to the area was felt with the closure of Scottish Coal opencast mines. Some of these are now being reopened again by Hargreaves.

Tourism is still seen as a potential growth area through making the most of the area's location, environment and rich heritage. The success of attractions like the Lochside House Hotel and Dumfries House and the growth of the Caravan Site in Afton Glen are positive signs.

TRANSPORT AND ROAD LINKS

New Cumnock is on the A76 and on the railway line between Dumfries and Glasgow with a station in the village. It has good access to nearby towns, motorways, and national rail routes. There is also a community mini bus service in the area provided by 'Coalfields Community Transport'.

EDUCATION

Primary Schools: New Cumnock Primary School and Nursery Centre

High Schools: Cumnock Academy and St. Joseph's Academy (Kilmarnock)

Further education: Ayrshire Colleges (Ayr, Kilmarnock and Cumnock Annex)

University of West of Scotland (Ayr)

COMMUNITY AND RECREATIONAL

Facilities: Town Hall; Games Hall and Gym, Open Air Swimming Pool, Community Centre, Churches, Library, Working Men's Club, Golf Course, Bowling Club, Football Pitches, Running Track, Greenhead Park, play area and playing fields.

Groups and Activities: There are a large number of local groups active within the community. They include Glenafton Community Development Group, Improving New Cumnock, New Cumnock Community Association, New Cumnock Community Council, New Cumnock Environmental Regeneration Volunteers, Afton Water Leisure, Afton Lily, Glenafton Athletic Junior Football Team, Glenafton Youth Academy,



New Cumnock Fishing Club, Age Concern, Art Club, Blue Angel Bikers, Heritage Group, History Group, Homing Pigeon Club, Newsletter Group, WRI New Cumnock, WRI Dalleagles, Passage to Monthraw, Young Farmers, groups that meet in the Baptist Church and Parish Church, recreation groups that use the Community Centre and Games Hall, uniformed groups (Girls Brigade, Boys Brigade, Scout Troupe), Youth Groups (EAC Youth Club, Pathhead Activity Group, The Railway Hub)....and others.

Events: Bank Pit Miner's Annual Reunion, Community Gala, The Herd's Fair.

The mining culture is still retained in local events – the Gala Day – in the local football club (Glenafton Athletics) and in the proud, close knit and resilient nature of the community.

HERITAGE

New Cumnock has links with 3 of Scotland's most iconic figures in history – William Wallace, Robert the Bruce, and Robert Burns. The Afton River is celebrated in the Burns poem 'Flow gently sweet Afton'. The Robert Burns Heritage Trail has been developed to allow locals and visitors to trace the footsteps of the local bard.

William Wallace and Robert the Bruce were both known to have spent time in the area. William Wallace is said to have held a royal house at Glen Afton and Robert the Bruce evaded capture in Glen Afton several years before the Battle of Bannockburn. King Edward II of England stayed for 10 days at Cumnock Castle (now the site of the Arthur Memorial Church) whilst in pursuit of Bruce.

The area also has links with the Covenanters - 'giving succour' to them in their 17th Century struggle for spiritual independence.

Its more recent history is closely associated with coal mining – and the miners memorials in the village and Knockshinnoch bear witness to that time and the losses endured. Prior to coal the area was mined for antimony, copper, lead and graphite.

ENVIRONMENT

Upper Nithsdale is an attractive area with hills, rivers, woods and farmland, cut through with Open Cast Mining. Environmental assets include the beautiful Afton Glen, the Nith and Afton Rivers, several community woods, and the reclaimed Knockshinnoch Lagoons Nature Reserve (walking area with bird sanctuary and hides). There is a network of local paths spreading out from the village into the wider countryside - routes include Afton Water, Glen Afton, Lagoons, Miners Walk, Pier Point and Afton Dam. The pools and marshland at Knockshinnoch serve as a migration stop for birds between the Clyde and Solway.

HEALTH AND CARE SERVICES

- 4 doctors operate from the new GP surgery which also provides a range of primary care services and Clinics
- There is a Community Hospital in Cumnock and hospitals in Ayr and Kilmarnock with A&E departments.
- East Ayrshire Council provide care at home, community alarms, community meals and home adaptations.
- Sheltered Housing is provided in the village with 35 units.
- Statistics show there are a number of health inequalities that need to be tackled including alcohol and drug conditions, chronic pulmonary disease, and smoking during pregnancy.

NEW CUMNOCK 2020 OUR VISION FOR THE FUTURE



This statement has been prepared to summarise the main aspirations for the future as expressed by local people and organisations in their replies to the survey and stakeholder interviews.



To have a main street where the buildings are used and it is a pleasant place for people to live

'New Cumnock will be a friendly and attractive community to live in and visit that provides excellent amenities and services for local people and visitors. We will make the most of our local heritage and environment and develop a healthier local economy.'

Better places for young people to go and be active – to engage young people in community projects



For New Cumnock to be seen for what it is already – a vibrant supportive community with economic activity - craft centre, heritage centre, that will draw people into the area and boost the local community spirit.

MAIN STRATEGIES AND PRIORITIES



These are the main strategies and priorities identified by the local community through profiles, surveys and interviews, which were further prioritised at the Community Event.

MAIN STREET AND TOWN CENTRE REGENERATION

The village gives a poor impression that belies the true nature of the place and its attractive setting. Its appearance affects its economy and its spirit and needs revitalised. Derelict buildings, sites, and poor exteriors of some of the housing all need remedied. People want to see regeneration of the village's central core and to create an attractive 'main street' with focal points, parking areas, and quality open spaces. One of the top priorities at the community event was to knock down the Crown Hotel and create much needed parking space for locals and visitors.

Main priorities

- Develop an agreed 'master plan' for the restoration and refurbishment of the main street and then take action on priority projects.
- Develop programme of village enhancement – 'keeping New Cumnock beautiful'
- Reduce heavy traffic through the village/traffic calming
- Improve the external condition of council and private let housing

COMMUNITY AND RECREATIONAL FACILITIES

New Cumnock has a number of community and recreational facilities many of them now not fit for purpose or needing revamped and under review by the local authority.

The key aspirations that are high priorities for the community are to save existing facilities, redevelop the Town Hall, and to develop the community owned swimming pool (one of our main assets) and integrate it with the council run Games Hall – to create a modern recreation centre. Both the Town Hall and a developed and modernised recreation centre are seen as having the potential to be attractions to outside visitors as well as core community and recreational facilities for locals.

Main priorities

- Save, restore and make best use of the Town Hall
- Support the improvement and promotion of the Swimming Pool
- Develop an integrated Sports and Community Hub
- Improve facilities for young people

MAIN STRATEGIES AND PRIORITIES

LOCAL ECONOMY, TOURISM AND JOBS

There is thought to be an opportunity to develop the tourism based economy of New Cumnock by making the most of its location, potential for outdoor recreation, heritage, and its local produce, arts and crafts workers.

The aims identified by the community are to make New Cumnock more attractive both as a place to stop if you are passing by, and also as a place to choose to visit. A package of measures to encourage people to stop as they travel along the A76 would need to include: better parking, amenities like a local café, and more interpretation and information. It was felt that more could be made of New Cumnock's status as a gateway to Ayrshire.

There are also ideas to develop outdoor recreation and heritage centres that would provide a focus for attracting visitors to the area. Similarly the development of accessible arts and crafts workshops, a micro brewery, and market days would serve as attractions to boost the local economy and make the most of local skills, produce and resources.

There is a recognition though that people without work in the area need to be supported and be able to access job and training opportunities in East Ayrshire and beyond and we need to ensure that there is good local access to this type of support.

Main priorities

- Make New Cumnock a welcoming place to stop in if you are passing by
- Make New Cumnock a 'destination' worth visiting
- Develop and promote local produce, arts and crafts
- Access to training and jobs services

ENVIRONMENT, HERITAGE AND OUTDOOR RECREATION

The local environment of Upper Nithsdale and Glen Afton have the potential to be made more of – through the development and promotion of cycling, walking, horseriding and canoeing.

The consultation identified community interest in building on previous work done and to look at ways of developing an Outdoor Recreation Centre. This would involve continuing to improve and promote paths; cleaning the rivers for canoeing; developing bike and canoe hire; and providing café and accommodation facilities.

Similarly there were opportunities to make more of the local heritage – building on the work already done to develop and promote a heritage trail and in particular to explore the establishment of a Heritage Centre.

Main priorities

- Develop and promote walking, cycling, horseriding and canoeing
- Clean up rivers – Afton and Nith
- Develop outdoor recreation centre
- Develop Heritage Centre and trails

ACCESS TO SERVICES & TRANSPORT

There was a strong sense from the consultation that New Cumnock was seen as being on the periphery of East Ayrshire and that it needed to ensure that it was not forgotten and that it retained and developed its access to services. The need to have a greater police presence, improve public transport, and doing more to cater for the ageing population were all highlighted

Main priorities

- Retain local council offices
- Increase police presence
- Improve public transport
- Develop services for the elderly
