

Introduction

In the pages which follow, detailed information is provided on the full range of performance information that is reported by the Council. This data falls into two categories, namely ‘Corporate Management’ and ‘Service Performance’.

It should be noted that for a number of indicators, 2021/22 performance data is not yet available. This is due to a time lag in the production of the data and relates mainly to indicators which are collected by agencies external to East Ayrshire Council.

A total of 55 SPIs are included in the performance framework for the 2021/22 reporting year. Statistics previously provided for Cabinet may differ due to the application of updated methodology or availability of refreshed data. Where available, comparable data for the previous years has been provided.

Performance data covering the last three financial years is included, where available. Additional information in relation to performance has been provided in the Notes Section, which follows the tables provided below.
