Bellsbank Early Childhood Centre is a nurturing centre, with a focus on building relationships with Parents/Carers and the wider community.

Parents/Carers are encouraged to speak to their child's key worker about any concerns regarding their child's learning, progress and wellbeing. Our Depute Managers and Senior Early Learning & Childcare Practitioners are also happy to speak to Parents/Carers about any concerns they may have.

Donald Currie is our Safeguarder. If Parents/Carers have any concerns regarding Child Protection they can talk to the Safeguarder in a confidence.

If Parents/Carers wish to make a formal complaint they can do so either to East Ayrshire Council or The Care Commission. (See Section 3 for details)

Children and young people who have been identified as having additional support needs will be supported through an Action Plan (AP), Individual Learning Plan (ILP) or in some cases a Coordinated Support Plan (CSP).

You and your child will be fully involved in developing these plans at all stages.

The School/Centre Day and Year

Bellsbank Early Childhood Centre is a 52 week establishment and is open Monday - Friday. We are now providing 1,140 hours of Childcare to children aged 2 and above, in line with the Scottish Government's 'A Blueprint for 2020: The Expansion of Early Learning and Childcare in Scotland'. Attendance and Timekeeping

We encourage parents/carers to bring their child to the centre in time for the beginning of their sessions. The door to the playrooms are open for the first ten minutes of each session, after which parents/carers will have to ring the doorbell to gain access.

Children arriving on time is important as it reduces disruption to sessions and prevents your child missing out in their learning and play experiences.

Reporting an absence

Please call the centre at least 10 minutes before the start of session if your child is going to be absent for any reason. Failure to do so means your child will be marked as an unauthorised absence.

Dress Code

Children in Bellsbank Early Childhood Centre are not required to wear a uniform however we do sell t-shirts, polo shirts and sweatshirts with our logo on them in a variety of colours if you wish to purchase one for your child.

Security and Visitors

All visitors to the Centre should report to the Main Office and sign our visitor's book. Visitors will be provided with a badge and lanyard which details our Child Protection

Policy. The entrance to the playrooms is secured by an electronic lock and only staff have access.

School Canteen Facilities, including use of Parentpay (*we will provide links to Free School Meal entitlement etc.*)

Snacks and meals are provided by our on-site kitchen. All children receive at least one snack per day, and may also receive a second snack and/or a meal dependant on their sessions.

Complaints Handling

We encourage Parents/Carers to speak directly to the management team if they have any complaints about any element of the services we provide.

Emergency Procedures / Medical matters

In the event of an emergency or severe weather closures, we have well-established procedures in place to cope with almost all situations:

- Group Texts are sent out to parents to advise of an emergency. Parents should provide the centre office with an up to date mobile phone number to enable automatic contact via text messaging.
- In the event of an emergency, the Council's Communications Team work quickly to update the Council website, Facebook and Twitter with the latest developments and advice on what to do.
- The team also work closely with WestSound Radio (DAB 11B, MW 1035) and West FM (96.7, 97.5 and 106.7) and statements and updates are issued frequently.

We understand an emergency can be a very stressful time and phone lines are often used by emergency services, so it's important that we try and keep lines clear.

It's essential that you let us know of any particular medical conditions or requirement(s) your child might have. Written parental consent is also required for the administration of medicines.

Please let the school/centre know of any change in your contact information, any change in a child's medical condition and of arrangements we should make should your child become ill, or need to be taken home.

Data Protection

We operate under the General Data Protection Regulations 2018 legislation.

For some activities, we may need to process more sensitive personal information about you for reasons of substantial public interest as set out in the Data Protection Act 2018. It is necessary for us to process more sensitive personal information for a number of reasons, these include:

- to carry out key functions as set out in law.
- in order to meet our legal obligations in relation to child protection.
- in order to protect your vital interests or the vital interests of others in circumstances where we will not be able to seek your consent.
- where this is necessary for the establishment, exercise or defence of legal claims.

SECTION 4

The Curriculum

Learning and teaching are at the heart of an effective curriculum. How children learn is as important as what they learn. High quality interactions and experiences are a key factor in successful learning and in raising attainment. Our Learning, Teaching and Assessment Policy sets out our expectations for a consistent 'whole school' approach to learning, teaching and assessment. As an ECC we strive to evaluate and improve our practice so that the education and care we provide grows and changes to meet the needs of the children in our care. Staff are creative in the ways they encourage children to participate in planning and reflecting on their experiences and developing their next steps in learning.

In line with Building the Ambition, Curriculum of Excellence and Pre-Birth to Three documents, we ensure that we have a holistic approach to children's learning and development which includes a stimulating environment, warm responsive relationships and developmentally appropriate experiences.

Family engagement is at the heart of the Centre. Through strong relationships with pupils, parents/carers and staff we have established a loving and nurturing Centre, where children feel safe and secure. Staff ensure regular contact with parents allowing families to share children's achievement, interests and progression. This the bases of planning for children's learning experiences.

Our 0-5 years olds benefit from exposure to a wide range of learning and teaching approaches and methodologies, including: learning through play; active learning; collaborative learning; problem solving approaches; effective and creative use of ICT; outdoor learning; nurture and partnership working, and intergenerational and community learning. Our learners are challenged, engaged and motivated. They are active in their learning and given opportunities to develop and demonstrate creativity. Our learners develop the skills and knowledge needed to transition successfully into Primary 1.

SECTION 5

Achievement and Improvement

During the last year we have seen a number of changes due to the expansion of hours. The care and wellbeing of children has continued to be at the heart of our provision. An important part of this is the practitioner's use of the GIRFEC wellbeing indicators to establish positive meaningful relationships with parents, carers and children. This is continued through a variety of activities which encourage family engagement for children 0-5 years.

We offer a range of activities to families with young children within the local community from the earliest stages of the child's life.

Our community practitioners have been surveying parents on new and innovative ways to involve them in the life of the centre.

Changes to our management structure has allowed for greater focus on developing our 2 year old provision in line with the Scottish Government's study on the quality of early learning and childcare.

We will continue to develop our provision as we move to expansion to 1140 hrs in 2020.

Our communication champion has successfully ran a number of workshops to provide families with strategies to support their child's language and communication skills.

Continue to be a significant member of the 'Get Doon to Chat' initiative which supports children's communication throughout the Doon Valley.

Our main focus has been the development of our environment both indoors and outdoors. This has enabled practitioners to offer children access to quality experiences which promote the different ways in which they learn. This has included making links within the community to expand children's real-life experiences.

We are currently preparing to move in to our brand new building, which will enhance our current learning provision and experiences. We are expecting to transfer to the new building in early 2020.

The publication of the report from our recent joint HMIE and Care Inspectorate inspection will influence our future improvement agenda. We will continue to focus on building nurturing relationships and developing holistic approaches to securing children's progress.

SECTION 6

Assessment

Staff employ a range of approaches for tracking and assessing children's progress with a focus on literacy, numeracy and health and wellbeing. Information is gathered from a variety of sources including observation, samples of children's work and conversations with parents and is evidenced within children's individual profiles of learning. This information is used to plan next steps in learning.

Assessment information is shared with parents; daily on an informal basis when key workers are in contact with parents, termly at individual plan meetings where next steps are agreed, twice a year at formal parent's evening's and at times of transition between rooms and on to other establishments or Primary 1.
