**NOTICE OF PROPOSED ORDER TO EXEMPT LAND FROM ACCESS RIGHTS**

Notice is hereby given under section 11(2)(b) of the Land Reform (Scotland) Act 2003 (“the Act”) that **East Ayrshire Council** proposes to make a section of the **Lugar Walk Order 2024** (“the Order”) under section 11(1) of the Act.

The effect of the Order will be to exempt from the access rights, which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act.

The purpose(s) for which the Order being proposed is to close a section of the footpath due to health and safety concerns that have arisen due to storm damage to the path.

It is currently unknown how long this closure will be required for and therefore this order will exempt access rights until further notice. An alternative route is not available.

Please note that the path has already closed as an emergency measure due to the health and safety hazard. We were unable to give advance notice of this emergency closure due to the circumstances.

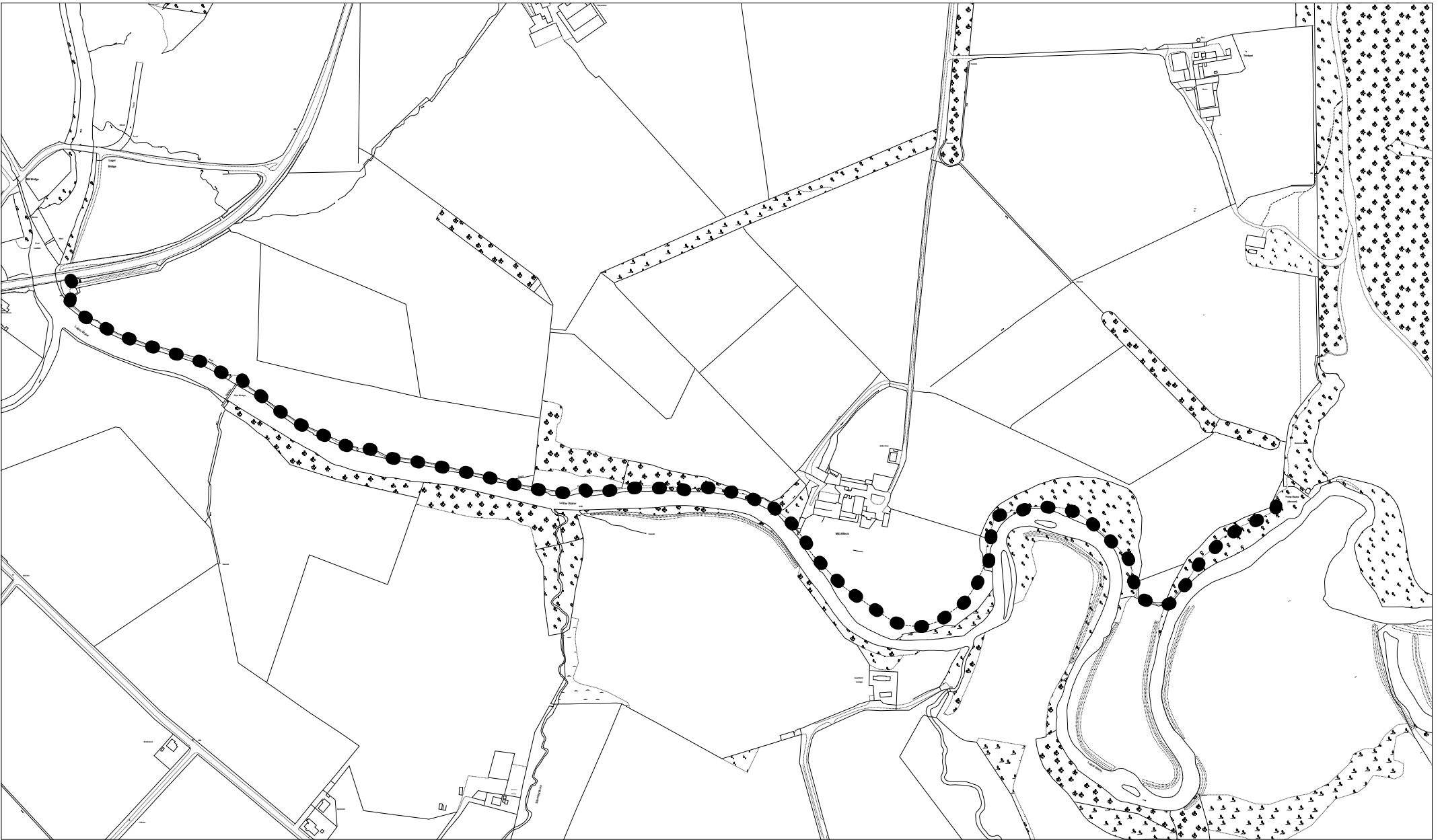
